At central exchanges you will store your crypto coins at the exchanges. At decentralized exchanges you keep in control of your crypto coins in your own wallet.

Usually, it is observed that, as soon as the token sale goes public, private investors buy a large number of tokens at a low price. At some point, these investors will sell their tokens to the general public with huge profits. With the IDO fundraising approach, companies, especially start-ups, do not need a centralized exchange or permission to start the fundraising event. Everyone can organize or participate in an IDO, so it is not just reserved for private investors.

Fast Trading

Another advantage of IDO is that the coin introduced is immediately available and ready for trade. From the moment of introduction, everyone has the opportunity to buy the coin and sell it at a later stage of the IDO at a higher price.


Immediate Liquidity

Decentralisation- each member of the blockchain structure has access to the whole distributed ledger. This open-book policy among all participants creates high confidence that each transaction is valid and ensures the system's transparency.

Security- by using blockchain technology, transactions are encrypted and cannot be stolen. You have exclusive access to your crypto money. And no one, not even the publisher of the coin, has access to your money.

Now that the features of blockchain have been discussed, we can look at the applicability, purposes and advantages of blockchain technology. In the beginning, blockchain architecture was applied particularly in the financial sector. However, these days, this technology helps create software development solutions for cryptocurrencies, record keeping, digital notary, and smart contracts.

Blockchain architecture can lead to several advantages, such as costs reduction, improved security and privacy, visibility and traceability and validity. It is, therefore, self-evident that Wecoin uses the advantages of blockchain technology.


ARCHITECTURE EXPLAINED

A blockchain is an open financial ledger or record in which every transaction is authenticated and authorized. A blockchain is designed as a decentralized network of millions of computers, commonly referred to as nodes. It's a distributed database architecture in which each node plays the role of a network administrator who voluntarily joins the network. Since there's no centralized information in a blockchain architecture, a blockchain is literally impossible to hack.






